The document asks for views on the government's proposals for implementing the changes announced at Budget, and is also seeking further information about the current end uses of other rebated fuels, such as non-aviation kerosene and fuel oil.

Witnesses stressed how critical it would be to align the post-crisis recovery stimulus with the UK's goals on climate change, biodiversity and sustainable development – given the short window of opportunity remaining to keep global temperature rises to a manageable level. The Committee has since agreed to launch an inquiry looking at how to align any post-pandemic economic stimulus package with the UK's climate and environment goals.
