Science research funding in universities inquiry

This short inquiry will assess the current system of research funding for universities in England and Wales. In the light of possible changes to tuition fees resulting from the Government's Review on Post-18 Education and Funding, and the Government's commitment to a target of 2.4% of GDP to be invested in research and development by 2027, the Committee will investigate what impact these changes may have on the ability of universities to conduct high-quality scientific research.

Grocery Code Adjudicator inquiry

The Groceries Code Adjudicator (GCA) was created by the Groceries Code Adjudicator Act 2013, following concerns about unfair competition practices and abuses of power in the groceries market. The role of the Groceries Code Adjudicator is to ensure that 12 "designated" or "regulated" retailers comply with the Groceries Supply Code of Practice and treat their direct suppliers lawfully and fairly.

Rural broadband and digital only services inquiry

The Environment, Food and Rural Affairs Committee launches an inquiry into Rural broadband and digital only services. Broadband, mobile infrastructure and access to digital services remain a central issue for rural communities. The EFRA Committee intends to hold a short inquiry, following up on its 2014-15 inquiry into rural broadband and digital-only services, to examine the government's current proposals and delivery of digital connectivity to rural areas.
