ADEPT AUTUMN CONFERENCE 2019

Focus

Following several successful conferences in Manchester, the 2019 conference moves to a new location, Bath in the South West. This presents a great opportunity to give the conference a refreshed look and feel. Last year's successful conference had a focus on **delivering sustainable growth for thriving communities**.

Since the last conference there have been some significant shifts in public policy and attitude. We want to build on last year's success and address some of the big issues coming to the fore for place directors. In particular, the comprehensive spending review, delivering place services and connectivity in a post-Brexit world, and a renewed focus in our communities on climate change. The focus of the conference in 2019 is **well-connected places in a changing world**.

The aim of the Autumn Conference is to build on the three strategic priorities from the Spring Conference, thus creating a coherent narrative for the year. The focus is about our role as place leaders (place directors, LEPs, combined authorities and as corporate partners) in enabling and delivering sustainable communities in a time of uncertainty and change, helping our communities to thrive and achieve their ambitions.

Our Approach

It is impossible to look at the big issues - local government funding, the rising tide of public support to address climate change, the impact of Brexit - in isolation. These issues are all interconnected and dependent on each other. Similarly, place-based services do not exist in a bubble; they are part of wider financial and policy systems.

It is important to recognise and discuss how place-based services support and interact with other council services, such as adult and children's services and public health.

The conference will tackle these interactions and dependencies topics head on, discussing how as place shapers we can enable our communities to thrive.

Conference Themes

With the focus of the conference being on well-connected places in a changing world, we will explore what being **well-connected** means, digital as well as transport connectivity and mobility. We will look at the growing role of sub-national transport bodies and explore the future potential of 5G.

The Government's comprehensive spending review will take place this year, and this will set the **financial context** for place services going forward. The conference will provide an opportunity to examine how place services are provided in the context of wider local government services and relationship with LEPs. A **special chaired debate** (Question Time style) with organisations such as ADASS, ADCS and SOLACE will be a centre-piece of the conference.

The conference will also delve into the **post-Brexit world**, and the proposed Shared Prosperity Fund. We will explore the opportunities for **innovation** in this new world and hear back from our **'Live Labs'** projects, in a speed-dating-style session.

Europe has particularly shaped our approach to the **environment** and its protection. As we prepare to leave the EU, **climate change** is once again in the political spotlight, with lobbying groups appearing both nationally and locally. The aim is to hear from Government but also to invite one or two 'different' high-profile speakers, whose views we do not always hear first-hand, to provoke a debate about our role as place shapers and custodians of places for future generations.

Our **workshops** include an opportunity to engage with SMEs, to discuss the new highways sector deal, the delivery of clean growth and the relationship between environmental and public health. 2019 has also seen the launch of our ADEPT Leadership Development Programme, and we want to hear from those who have participated.
