were nowhere, help from DfT to allow them to improve buses. Keep an eye on this LA to see what they will do with the funding and partnership work they have received. Engagement with DfT is key. Key is knowing what DfT want from LA. Bid writing is also key. No impressive bids this time.

All successful offers will include instructions on indicative allocation. For those partially successful are you going to say what supporting? Think there will be a further round of clarification. Likely to give money as long as do as DfT ask. LA's need to be as competitive as possible.

Need LA to know how to bid more effectively. Interaction/work with DfT beforehand essential. There will be more rounds of funding. Eg an authority did not include parking in their original bid, but DfT saw this as essential to bid – it was assumed and not stated.

If not included, then will assume there is a reason for that. If cannot do immediately, then include why and if there is a way forward. Anyone who leaves information out thinks this is not going to be done. If not doing something, say why and what going to do about it. Read guidance. One submission said will work out risks once received money, DfT will think that this is too risky and will mark you down.

Next thing is what support package will look like for each authority.
